WHEN: September 26 - 27, 2015 (Saturday & Sunday)

WHERE: YMCA Camp Classen – Davis, Oklahoma (will camp in tents in 89er village – wilderness area)

WHAT: Opportunity to Fish and Hike. TFC Scouts will complete 5 mile hike plus other TFC requirements. TFC scouts need to keep daypack, water, lunch and snacks with them in vehicle – will go on hike when arrive at camp. All scouts who need to complete the Fishing merit badge will have opportunity to catch, clean, and cook a small fish. Bring a fishing pole (with your name on it) – troop will provide live bait and power bait, cleaning supplies and aluminum foil. Scouts can also play games in the large field area. Need to bring non-aerosol insect repellent.

DEPART: 8:00 AM, Saturday, September 26th

RETURN: 12:00 PM (Noon), Sunday, September 27th (Eat Lunch At Home)

Willow Bend Mall Covered Parking Garage by Macy's – lower level

COST: \$20.00 for youth and \$10.00 for adults. \$10.00 is for food the balance is for materials and transportation for the campout. Please pay in cash. Money is nonrefundable.

Eat a good breakfast before departure. Bring a sack lunch for Saturday, a nalgene/water bottle filled with water, your Scout Handbook, afternoon snack, plenty of sunscreen, non-aerosol insect repellent, and raingear. Be prepared for windy, cold, hot, sunny and rainy weather. Wear your Troop hat, Class "A" uniform and Troop t-shirt while traveling to and from camp.

Youth and adults (a separate form is needed for each participant) must return this RSVP/Permission Form, a signed Release and Waiver Form, and cash money (exact amount), \$20.00 for youth or \$10.00 for adults to your Patrol Leader in a sealed plastic sandwich bag on Monday, September 14th.

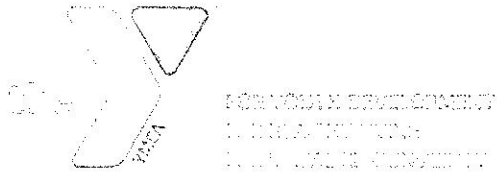

Release and Waiver of Liability and Indemnity Agreement
YMCA CAMP CLASSEN

In consideration for being permitted to participate in the programs of Camp Classen YMCA, including but not limited to observation or use of facilities or equipment, the undersigned, for himself or herself and dependent minors, personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she understands that despite the highest level of safety practices employed at Camp Classen YMCA, accidents can possibly occur. Therefore:

1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the YMCA, its directors, officers, employees, and agents (hereinafter referred to as "releasees") from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands on account of injury or death to the person participating in the camp program, whether caused by the negligence of the releasees or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein.
2. THE UNDERSIGNED HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releasees and each of them from any loss, liability, damage, or cost they may incur due to an injury or accident.
3. THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to negligence of releasees or otherwise while in, about, or upon the premises of the YMCA and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the YMCA.
4. THE UNDERSIGNED HEREBY AUTHORIZES THE YMCA to use photographs, slides, video tapes or digital images of the person name in this release for its records, public relations or internet programs.

THE UNDERSIGNED further expressly agrees that the forgoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Oklahoma and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements, or inducement apart from the foregoing written agreement have been made.
